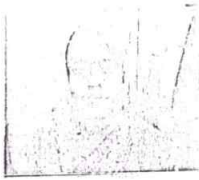
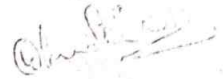
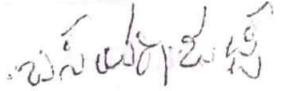
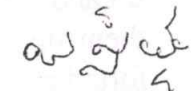
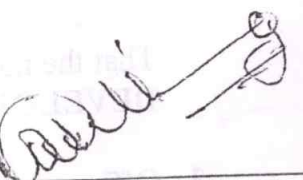
4. OBJECTIVES OF THE TRUST:

- q. To do all other law full things as may be incidental to or conducive to the attainment of the object of the trust.
- r. To amalgamate, take over, to deal and effectuate similar kind of existing trust with this trust, which deems necessary for the betterment of this trust.
- s. To promote, organize, administer, establish, support, maintain, and/or grant aid to any person, institution or society or organization whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.
- t. To promote, assist, and/or maintain all activities by whosoever carried on or wherever carried on in India in conformity with the object of the society and as are conducive to the well being and general welfare of the nation or are conducive for the advancement of any object or objects of general public utility not involving/carrying on any activity for profit.
- u. To provide medical facilities/treatment to the people of the country in the need of our.
- v. And generally to do all such acts, deeds and things as are incidental or conducive to the attainment and furtherance of the above objectives.

5. It is hereby further declared that:-

- a. The trust shall be for benefit of all persons belonging to whatsoever community and irrespective of caste, creeds and religions.

c. The trust created hereby is irrevocable trust.

d. The Income and/or trust funds shall be applied and/or accumulated to such charitable purpose in India.

e. The trust shall carry out any incidental activities for generation income, required for other activities, by constructing temples and Mathas.

f. The trust assets shall vest in the trustees who shall extend possessed of any vested with the said assets, under this deed on trust and shall be administered and manage by them subject to and in conformity with the provisions of this deed of trust.

c. The number of trustees shall not be less than three and more than seven subject to this condition, trustees, at any time, shall have the power to increase or decrease the number of trustees on the board. If the number of trustee falls below three, the trustee shall not except for the purpose of filling any vacancy, act, so long as the number is below the said minimum.

d. Any trustee, whether original or substitute under this deed during the tenure of his trusteeship dies or absent himself for four consecutive meetings of the board of trustees or for the calendar year, whichever is longer, without leave of absence or is convicted of a criminal offence involving moral turpitude, shall have no right to continue as board of trust or trustee.

- b. No amendments to the Trust Deed/Memorandum of association and Rules and Regulation shall be made which may prove to be repugnant to the provisions of Section 2(15), 11,12 and 13 and Section 80G of the Income Tax Act, 1961 as amended from time to time.
- c. The funds and Incomes of the Trust Shall be Solely utilized towards the achievements of the Objects and no portion of it shall be utilized for payment to trustees/members by way of profit, interest, dividends etc., except as salary to whose trustee who are working full time for the trust.

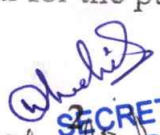
9. POWER AND FUNCTIONS OF BOARD OF TRUSTEES: -

1. PRESIDENT:

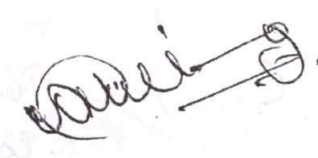
- a. To look after, manage and supervise the management of the trust and in general to acquire all things and do all acts necessary to carry out the objectives of the trust.

To authorize opening of bank accounts in the name of the Trust, trustees, and/or any institution run/conducted by the trust with banks, to operate such accounts and to give instructions to the banks, to provide for the opening and operation of appointment by the trustees may determine from time to time.
- d. To invest trust funds, to sell and/or release and/or vary or convert such investments.
- e. To purchase, acquire, sell, transfer, exchange, mortgage, assign, grant lease or sub leases, donate and/or otherwise deal in all movable property of the trust.
- f. To borrow or raise loans with or without security on mortgage charge hypothecation or pledge over all or any of the trust.
- g. To make arrange and/or obtain loans for the beneficiaries of the trust and to guarantee the same for securities thereof.
- h. To extent the funds of the trust in such a manner as most beneficial for the purpose of the trust.

- i. To negotiate and enter into contracts on behalf of the trust and rescind such contracts and to authorize a trustee or trustees from amongst themselves to execute such agreements or contracts on behalf of the trust.

To frame, make and enforce all such Rules regulations and/or bye laws, not inconsistent with the express provisions of this trust deed as the trustees may deem proper for securing and facilitating the administration and management in details of various departments relating to the activities and affairs of the trust for convening, conducting and regulating the meeting of the trustees and for appointing sub committees and general for the management and administration of the trust property and also from time to time repeal, amend, rescind or add to all such rules, regulations and bye laws and also to pass resolution in connection with all or any of the said matters at their meetings.
 - k. To appoint sub committees, Executive committees, advisory committees from amongst themselves and/or by co-opting members from general public and determining their terms of office and authority etc.
 - l. To appoint, engage, remove, dismiss or suspend employees and fix the terms of employment with the employees of the trust and to do all such other work in connection with the employees of the trust as may be necessary from time to time.
 - m. To do all acts and things to carry out the objectives of the trust and which are not inconsistent with any of the provisions of this presents. The entire control, regulations, management application and administration of the trust properties of any kind shall be in the discretion of the trustees.

- o. To join, co-operate or amalgamate the trust with other or others having similar or allied objectives, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objectives and nature of the trust.

2. SECRETARY AND TREASURER:

Subject to any direction given by the General Body in the General Body meeting, the Hon. Secretary/Treasurer shall perform the following duties:

- i. Keep Minutes of the proceedings of all the meetings.
- ii. Have care of both the movables and immovable assets of the Trust.
- iii. Have charge of all correspondence of the Trust.
- iv. Give notice of the Meeting of the Board of Trustees and committees formed.

- x. The Secretary/Treasurer shall ensure proper maintenance of the books of accounts of the forum.
 - xi. The Secretary/Treasurer shall be empowered to open bank account in any nationalized/scheduled bank and operate the bank account along with joint signature of either the President or the Secretary/Treasurer.
 - xii. The Secretary/Treasurer shall arrange to prepare the Annual Accounts of Income and Expenditure and have the same audited by a Chartered Accountant and present the same before the Board of Trustees of the trust.
 - xiii. In the absence of the President, the Secretary/Treasurer shall have powers and perform duties of the President.

10. MEETING AND PROCEDURE FOR MEETING:-

- a. The trustees shall meet at least once in three calendar months.
- b. Subject to clause (i) above the Trustee shall prescribe and decide the procedure for meeting including the agenda notice of meeting preparation and keeping of minutes and other matter.
- c. The quorum of the meeting shall be presence of three trustees.

11. ACCOUNTS: -

The trustees shall cause to be kept and maintained, proper and regular books of accounts of all properties, assets, liabilities, income, expenditure, receipts, payments, and all transactions concerning the activities of the Trust. On 31st Day of March every year a general account of all the assets and liabilities shall be taken and an income and expenditure account for the whole year and a balance sheet as on 31st March shall be prepared and passed by the trustees. The accounts of the trust shall be audited annually by a Chartered Accountant appointed by the Trustees for the purpose.

12. INDEMNITY: -

The trustee shall not be liable for any default, commission, omission or delay in performing or exercising any of the powers or trusts herein contained or any of them or in giving notice to any person for the executor hereof or in taking any other steps which may be necessary expedient or desirable.

14. DETERMINATION OF QUESTIONS:-

The trustee shall have full power to determine all question and doubts arising in relation to any of the provisions hereof and ever such determination made whether or not the proceedings of the Trustees shall be conclusive and binding upon all persons interested hereunder.

15. REFERENCE TO CHARITY COMMISSIONER:-

If any dispute arises about the interpretation or construction of any of the clause or provision of this deed, the matter shall be referred to the charity commissioner whose decision shall be final and conclusive

16. SAVINGS

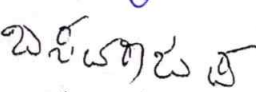
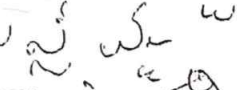

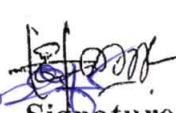
